Guide for Authors

GENERAL INFORMATION

Submission of an article implies that the work described has not been published previously, that it is not under consideration for publication elsewhere, that its publication is approved by all authors and tacitly or explicitly by the responsible authorities where the work was carried out. Upon acceptance of an article, authors will be asked to complete "Journal Publishing Agreement". After publication, your article will be available as a downloadable full-color document in .pdf format from the Journal of Building Chemistry website (article is freely available to wider public). The open access publication is without any author fees.

PREPARING YOUR MANUSCRIPT

Manuscript structure:

Title page: The first page should indicate the title, the authors' names in full and affiliations, and a postal and e-mail address of the corresponding author.

Abstract: The abstract should state briefly the purpose of the research, the principal results and major conclusions (max. 1500 characters with spaces).

Keywords: Immediately after the abstract, provide a maximum of 6 keywords. These keywords will be used for indexing purposes.

Introduction: State the objectives of the work and provide an adequate background.

Materials and methods: This section should describe and reference the techniques applied in the investigation.

Results and discussion: Results should be clear and concise.

Conclusion: This section should tie the major findings to the objective(s) stated in the introduction and suggest the practical or theoretical relevance of the manuscript to future research.

Acknowledgements: List here those individuals who provided help during the research.

References: Please ensure that every reference cited in the text is also present in the reference list (and vice versa).

Manuscript style & format:

Please write your text in English. The manuscript should be written as editable files only e.g. Word (.doc). Tables and figures should be at appropriate place in the text. The text should be in single-column format. Manuscript must be typewritten on A4 size with a font size of 10 pt (in Times New Roman), 1,15 spaced with a left and right margins of 2.5 cm, a top margin of 1.6 cm and a bottom margin of 2.0 cm. Keep the layout of the text as simple as possible. Please use page numbers in your manuscript. Divide your article into clearly defined and numbered sections. Subsections should be numbered 1.1, 1.2, etc. (the abstract is not included in section numbering).

Units, abbreviations and math formulae

Only metric units (SI) should be used in a manuscript. After the first appearance of a term in full, a standard abbreviation may be used. Please submit math equations as editable text and not as images. Equations should be numbered consecutively and referenced in the text (e.g. Eq. 1), for example $A = B + C$ (1)

Illustrations and tables

All figures must be numbered consecutively with concise descriptive captions and legends. Each figure must be clearly referenced in the text (e.g. Fig. 4). All illustrations must have sharp focus and good contrast.

Please submit tables as editable text and not as images. Number tables consecutively in accordance with their appearance in the text and place any table notes below the table body. Be sparing in the use of tables and ensure that the data presented in them do not duplicate results described elsewhere in the article.

Authors are responsible for obtaining and submitting to Journal of Building Chemistry permission from copyright holders for reproducing any illustrations, tables, figures or lengthy quotations previously published elsewhere.

References

Where applicable, author(s) name(s), journal title/book title, chapter title/article title, year of publication, volume number/book chapter and the pagination must be present. Use of DOI is highly encouraged. All citations in the text should refer to:

1. Single author: the author's name and the year of publication;
2. Two authors: both authors' names and the year of publication;
3. Three or more authors: first author's name followed by 'et al.' and the year of publication.

Citations may be made directly (or parenthetically). Groups of references should be listed first alphabetically, then chronologically. References should be cited in the following forms: (Smith 2010), (Jones & Taylor 2011) and (Williams et al. 2015). References should be arranged first alphabetically and then further sorted chronologically if necessary. More than one reference from the same author(s) in the same year must be identified by the letters 'a', 'b', 'c', etc., placed after the year of publication. Examples of reference listings:
